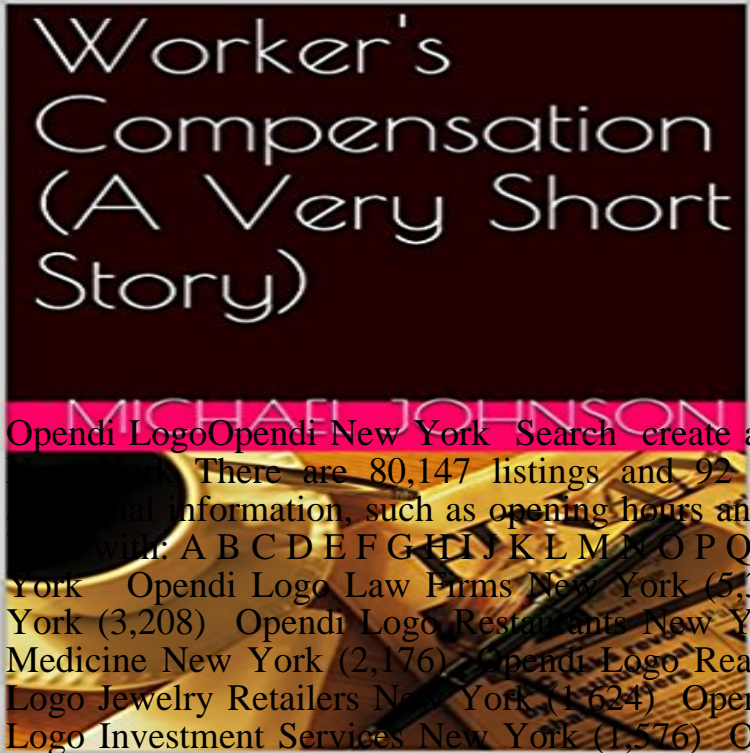


# Workers Compensation (A Very Short Story)
